NEW VETERINARY MEDICINE REGULATIONS

We mentioned in last month's newsletter that as from 1st February 2025 the use of antibiotics for prophylaxis (= <u>preventative</u> use of antibiotics such as antibiotic footbaths, blanket use of antibiotic dry cow tubes on all cows at dry off or blanket use of antibiotics on all lambs at birth to prevent rattlebelly) is now prohibited other than in exceptional circumstances.

If required, a vet will need to provide a clear rationale, which must be documented, for every prescription of antibiotic for preventative use (prophylaxis) and that a management review including a premises visit should be carried out as close to the time of prescription as possible and definitely within 3 months. The same protocols will need to be applied whether your farm is Red Tractor Assured or not.

HAVE YOU SCANNED YOUR SHEEP YET?

Just a little reminder for those who have scanned their flock to forward their scanning data to the surgery. This information will be extremely useful at your annual health and performance review visit. We have had mixed feedback regarding scanning, with some clients informing us of lighter scans. A scan revealing a geld rate of over 2% is abnormal and we strongly recommend looking into the possible causes. Blood sampling geld/barren sheep to identify Enzootic and Toxoplasma abortion is once again subsidised this year by MSD via flock check. To

DEALING WITH SHEEP ABORTIONS

Sadly, we have already seen several cases of sheep abortion this year. For those who are unfortunate to experience this, please see below guidelines of how to deal with abortion cases in your flock.

- Always assume that any ewe which lambs prematurely as well as its lambs, afterbirths and vaginal discharges are contagious to other sheep, so isolate her from all other sheep including ewes which have already lambed and geld hoggs.
- Remove aborted lambs, afterbirths plus bedding that may have been contaminated from the lambing environment.



- Aborting ewes and their lambs/afterbirths are potentially contagious to humans so always wear gloves when handling abortion material.
- PREGNANT WOMEN SHOULD AVOID CONTACT WITH ABORTING EWES.
- If you have over 2-3% of sheep aborting or re-absorptions, mummified lambs or weakly live lambs it is likely that there is an infectious cause of abortion present which should be investigated to determine the cause. Collect freshly aborted lambs and afterbirths, double bag them in leakproof containers and contact the surgery to arrange to drop off for investigation.
- Do not bring abortion material into the surgery building we have a clearly labelled yellow salt bin for samples which is located outside the farm building at the bottom site.
- The more information that we are given; the number of ewes aborting, the age of the ewes, how far off lambing, are the aborting ewes off colour, are they purchased or homebred, did you have abortions last year, have they been vaccinated for either Toxo or Enzo, the better advice we can provide.
- If abortion material is not available for testing there are subsidised blood testing schemes available (free lab fees, you
 are only charged for taking of the blood samples) to check for antibodies (evidence of exposure) to Toxoplasma and
 Enzootic abortion. These samples can be taken at any time in the 3 month period after the abortions.

The product also contains calcium as ewes with twin lamb disease can also be short of calcium. Established cases of twin lamb disease will become dehydrated and benefit from oral fluids and electrolytes which can be supplied by mixing a **Selekt Restore** sachet into drinking water.

PRE-LAMBING CLOSTRIDIAL BOOSTERS

Pre-lambing boosters should be administered approximately four weeks pre-lambing to ensure maximum protective antibodies in the ewe's colostrum.

We do not anticipate any supply issues with straight clostridial vaccine supply (e.g. Bravoxin, Covexin 10) but there are ongoing availability issues with combined clostridial/ pneumonia vaccine (Heptavac-P).

The latest update from our MSD representative has informed us that Heptavac-P is due to be available early February but amount and bottle sizes will be limited.

We are taking orders for Heptavac-P and placing clients on the list on a first come first served basis. To place your order please contact the surgery.

HUSKVAC (Lungworm Vaccine) FOR CALVES

The best way to protect first season grazers is through lungworm vaccination with **Huskvac**. Calves should be at least 8 weeks of age before vaccination and 2 doses of vaccine are required with 4 weeks between the first and second dose. The second dose should be administered at least 2 weeks prior to turnout.

Last year we did experience disruptions in supply. If you could let us know sooner rather than later how many doses you require and for when, we will try our best to order in your first and second doses, all depending on the expiry dates of that batch.

UPCOMING MEETINGS

RESPONSIBLE USE OF MEDICINES REFRESHER COURSE

Another requirement of the new legislation and revised Red Tractor Standards is that dairy farmers and their staff will need to refresh their medicine training course every 5 years to keep up with the latest practices in responsible medicine use. At least 1 person on the unit must have undergone training in the last 5 years.

Please contact the surgery if your dairy farm assurance is due for renewal and you need to attend a course.

CATTLE MEEING—MYCOPLASMA BOVIS

Mycoplasma Bovis (M Bovis) is a widespread bacterial disease that most commonly causes respiratory symptoms in calves and occasionally other chronic health issues such as head tilt, septic arthritis or mastitis. We have been carrying out Mycoplasma screening on numerous farms and finding evidence of exposure to infection on a significant proportion of those tested.

During the meeting we will be discussing the impact of Mycoplasma infection, its treatment and control including a new M Bovis vaccine on:
